## Would NMED be willing to accept the SWANA MOLO in addition to the current training?

Individuals still need to know the New Mexico Solid Waste rules and they would need to be certified through the state. Both Initial and Renewal.

Rafael: Could there be a smaller course that only speaks to the Rules that could be used in addition to training provided by SWANA?

Joan: Initial Certification has to be through the State course. Renewal can use MOLO and other SWANA training to satisfy the CEUs as long as they are pre-approved by NMED.

## Also on line courses have ways to ensure that the students are legitimately in the class and taking the class.

Joan: NMED would be interested to discussing a NM SWANA host the courses. They are currently committed to providing 8 classes this year. They do not see a demand beyond that number of classes currently.

As for online courses they looked into it and their IT department indicated that they do not currently have the technology to pull this off.



### What is the support that NM SWANA provides for the training?

Guest presenter from NM SWANA as subject matter experts. NM SWANA also provides travel reimbursements for speakers. NM SWANA also provides registration.

NMED handles the printing, incidentals(coffee, snacks, etc...), and rental with NM SWANA handling the reimbursement.

### Would it be possible to hold the courses in on single location?

NMED likes going throughout the state so that they can also use it as an outreach opportunity to the various operators throughout the state. Operators also like to see the other facilities. There are tradeoffs in each scenario. This conversation could be ongoing.
